The Board of Education is seeking residents who wish to be considered to serve on a 72-member Facilities Use/Grade Configuration Study Focus Group. Deadline to apply is October 7.

Once selected, the group will meet on Saturday, October 26, from 8am to 4pm, to examine the recommendations presented to the board by consultants at their July 11 meeting.

Last school year, the board charged consultants Hunt Engineers and Architects and Dr. Paul Seversky with examining the district in-depth and providing recommendations that would save district resources, in light of diminishing funding and budget deficits in recent years.

The consultants provided 13 different recommendations, many which close schools, change the reconfiguration of grades, and include construction costs, with various savings. Four additional options have been added since the July 11 meeting, so the focus group will examine a total of 17 options.

The focus group will be asked to review, discuss, and identify the possible opportunities and challenges of each recommendation.

“We’re looking for residents who are interested in serving the students of our district, who have the ability to listen to all sides of an issue, can see the ‘big picture’ yet can also appreciate and understand details and challenges, and who can articulate their thoughts effectively,” said Board of Education President Brian Lynch.

The focus group will include representatives from all areas of the district, including parents of students from all schools, businesspeople, retirees, area officials, and more.
